**New Parent Support Program (NPSP)**

Has a team of social workers and nurses who provide in-home & classroom education service for parents of children through five years of age.



**Community Counseling Program (CCP)**

Offers individual, couples, family and group therapy. Manages care for the Marine Intercept Program (MIP) for Marines at risk for suicide. Workshops, briefs, and classes upon request.



**Substance Abuse Counseling Center (SACC)**

Provides screening, assessment, education, and counseling to those struggling with alcohol and drug related problems. The Drug Demand Reduction Program (DDRP) and the Alcohol Abuse Prevention Program (AAPP) coordinate services to provide multiple prevention and educational options on and off the installation.



**Family Advocacy Program (FAP)**

Provides individual, couples, family, and group counseling as well as prevention classes and services for families affected by domestic violence and/or child abuse or neglect.

**Sexual Assault Prevention and Response Program (SAPR)**

Serves victims of sexual assault who are active duty service members and dependents 18 and older. Provides advocates in time of need. SAPR engages in safety planning, identifying resources and exploring reporting options for every client.
